

Date: 6th March 2021**MEMORANDUM OF UNDERSTANDING**

This Agreement made and entered into on this 6th March 2021 between **KARTAVYA-The Career Assister** (hereinafter called K-TCA) situated at Kishoreganj, Road No. 4, Ranchi- 834001 and **Bokaro Steel City College** (Hereinafter called "B.S.City College" which expression shall include its successors and permitted assignees) with its registered office at Bokaro, Jharkhand- 827005.

1. OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is

- a. To promote interaction between K-TCA and COLLEGE in mutually beneficial areas.
- b. To provide a formal basis for initiating interaction between K-TCA and COLLEGE.

2. PROPOSED MODES OF COLLABORATION

K-TCA and COLLEGE propose to collaborate through

- a) Providing student "PROFESSIONAL RECRUITMENT TRAINING along with Computer Communication, English Communication and Entrepreneurship (Seminar and Workshop)" for UG students and assisting college in placement activities like Campus Recruitment Drive at COLLEGE Campus and Placement Lessening as well (all the placement activities which are mentioned under this MOU will be taking care by recruitment partner of K-TCA "RACION CONSULTING (OPC) PVT LTD".
- b) The eligibility criteria for student selection in campus recruitment will be as per company's norms.
- c) Handling placement data of COLLEGE and providing as per COLLEGE needs.
- d) Training of COLLEGE students through continuous Training Programs conducted by K-TCA in PRE PLACEMENT TRAINING to COLLEGE.
- e) Any other appropriate mode of interaction agreed upon between K-TCA and COLLEGE.
- f) College is assigned for providing and enrolling students under training program of K-TCA and assuring in batch freezing also.
- g) No. of students in each semester will be at least 250 and in each batch will be of 50, will be assuring by the college only.
- h) Enrollment fee of training program will be taking care by college only from their students and paying to K-TCA as per program fee whatever K-TCA is charging (find the attachment of program fee).
- i) Enrollment fee of training program is subjected to change as per K-TCA norms and college will have to agree with these changes.
- j) Also, college is assigned under this MOU to provide class room and IT lab (with all IT equipment's whatever K-TCA will required in their training program) to K-TCA for training only.

Each of the above modes of interaction will be initiated by entering into a separate agreement between the two parties.

3. CONFIDENTIALITY

- a. During and for a period of three years from the date of disclosure, each party agrees to consider as confidential all information disclosed by the other party in written or tangible form or, if orally disclosed confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.
- b. The obligations above shall not extend to any confidential information for which the receiving party can prove that this information:
 - Is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party.
 - Is already known or become known to the receiving party
 - Is received from a third party having no obligations of confidentiality to the disclosing party,
 - Is independently developed by the receiving party, or
 - Is required to be disclosed by law or court order.

4. NON-EXCLUSIVITY

The relationship of both the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind.

5. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of both the parties, shall expire in 3 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of both the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days of prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

6. RELATIONSHIP

In this MOU shall be construed to make party a partner, an agent or legal representative of the other for any relevant purpose.

7. ASSIGNMENT

It is understood by the Parties herein this MOU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

Both Parties shall not be bearer any type of respective costs of carrying out the obligations under this MOU

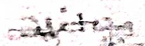
9. SIGNED IN DUPLICATE
